**DEADLINE FOR MEMBERSHIP APPLICATION IS AUGUST 14, 2010 TO ENTER MANDAN.** The National and State applications must be received by this date—along with current grade report. They need to be forwarded on to the NHSRA office before you are an official member. Before your application can be processed you must include:

- 1) The National and State application forms, completed front & back. **The minor release forms must be signed by both parents or a legal guardian and the member and it must be notarized.** Please note: **All three people must appear before the notary!!**
- 2) A copy of your final spring 2010 report card. If you competed at the state finals, you do NOT need to send another report card! This requirement is mandated by the National High School Rodeo Association as printed on pages 26, 27, & 28 of the National Rulebook.
- 3) **Membership Dues: Fee of \$150.00 made payable to the NDHSRA.** The \$150.00 fee is divided as follows: \$26.00 membership dues in the NDHSRA, \$35.00 membership dues in the NHSRA (includes sub. To Western Horseman magazine), \$15.00 for the NDHSA Times, and \$74.00 for medical insurance. All items *must* be paid.

***If the items listed above are not complete your application will be returned and a \$5.00 fine will be charged.***

You must also be eligible with your school – any tobacco, alcohol, etc. violations are the right of your school to enforce.
